Dear Friends,

It is my pleasure to welcome you to Collegiate Directions, Inc.'s 9th Annual Spring Benefit. The CDI community—our Board of Directors, 228 active Scholars, 156 alumni, and 811 students at our college advising consultation partner schools—is excited to celebrate this year's accomplishments with you tonight.

Over the last 14 years, the CDI team has worked diligently to execute against its vision to address the edu-

cation opportunity gap for low-income, first-generation-to-college high school students. Today, more than 300 CDI Scholars have matriculated at over 85 selective, four-year colleges and universities across the country and have a 97% college graduation rate versus the 11% national average for their peers. Our three-pronged core mission remains very relevant today as CDI works to: (1) identify gifted, lowincome, primarily first-generation-to-college high school students and helps get them to and through college; (2) create leaders by serving as mentors for the personal and academic goals of our Scholars; and (3) leverage its college counseling expertise and partner with high schools to improve their college advising operations. A unique attribute of our approach and the cornerstone of our success is that we stay with our Scholars for six years. We also work closely with families along the way; their engagement is an important factor in each Scholar's journey. Our approach is intense and emphasizes hard work and responsibility on the part of our Scholars to actualize their academic goals. Your support helps them graduate from college in the face of multiple barriers and it also facilitates their entry into the workforce. We appreciate your partnership with us.

Through our School Support Program, we work with partner high schools to enhance their college advising offices by developing college-going practices based on their self-identified areas of need. E.L. Haynes Public Charter School and D.C. International School together enroll 811 high school students that benefit from CDI's comprehensive college advising consultation services.

Our youth are our future, thank you so much for investing in them. We are grateful that you have chosen to join us this evening as we celebrate our mission to help more Scholars fulfill their dreams. We hope that you are inspired by our work and continue to be a champion for our cause to help our Scholars, alumni and partner high schools to Achieve What's Possible!

"Aggie" earned a bachelor's degree in Economics from Connecticut College, and a Master of Business Administration from Columbia University Business School.

Aggie served as Headmistress of National Cathedral School, Washington, D.C., from 1989-2003. She formerly served as Headmistress of Garrison Forest School in Baltimore, MD from

1978-1989. Her board leadership experience includes: President of the Headmistresses Association; President, the Headmasters Association; President, National Association of Principals of Schools for Girls; Vice-President, Country Day Headmasters Association; Vice-President of A Better Chance; Trustee, Washington Episcopal School; Canon, Washington National Cathedral; Chair, National Association of Episcopal Schools' Bicentennial Conference 2004; Trustee, National Association of Independent Schools.



THE HONORABLE ERIC HOLDER, JR.

82nd Attorney General of the U.S.

Eric Holder, Jr. is a partner at Covington & Burling LLP. He served as Attorney General of the United States from February 2009 to April 2015. As the third longest serving Attorney General in U.S. history and the first African American to hold that office, Mr. Holder is an internationally recognized leader across a broad range of regulatory enforcement, criminal justice, and national

security issues. In 2014, Time magazine named Mr. Holder to its list of 100 Most Influential People, noting that he had "worked tirelessly to ensure equal justice."

Mr. Holder attended Columbia Law School where he clerked at the NAACP Legal Defense Fund and the Criminal Division of the Department of Justice. Upon graduating he moved to Washington and joined the Department of Justice as part of the Attorney General's Honors Program. He was assigned to the newly formed Public Integrity Section and was tasked with investigating and prosecuting official corruption at the local, state and federal levels.

In 1988, Mr. Holder was nominated by President Ronald Reagan to become an Associate Judge of the Superior Court of the District of Columbia. In 1993 President Bill Clinton appointed him U.S. Attorney for the District of Columbia. In 1997, President Clinton named Mr. Holder as Deputy Attorney General, making him the first African American to hold that post.



AFRAAH KARAMA

American University Class of 2019

Afraah Karama is a member of CDI's high school class of 2015 (Walter Johnson HS) and will graduate from American University this spring with a degree in Accounting and a cumulative GPA above a 3.5. Last summer, Afraah completed an internship with PricewaterhouseCoopers in Vienna, VA. At the conclusion of her internship, she was offered a permanent, full-time position to commence upon graduation. Afraah decided that she wanted to


stay at AU an extra year to earn a Master of Science in Analytics. PricewaterhouseCoopers agreed to hold her offer open until she completes her studies in August 2020.


SCHOLARS PROGRAM




Students enrolled in the CDI Scholars Program since 2005



Mental Health

Like all students, CDI Scholars face a range of social and emotional challenges. Those challenges can range from academic-related anxiety and problems balancing family responsibilities with schoolwork to coping with the loss of a parent. Our

mental health counselor meets with every high school student enrolled in the Scholars Program to help them address and work through these issues.

377% of those who report symptoms of depression or anxiety say they have received counseling or therapy for mental or emotional health from a health professional in the past 12 months.


